



IFA Certified Account Executive in Factoring Exam

The International Factoring Association (IFA) is accepting applications for candidates who wish to register to take the CAEF exam. Successful candidates will earn the CAEF designation by receiving a passing grade on the exam. This prestigious certification provides proof that an individual has met the benchmark skilled and knowledge to operate effectively in the Factoring and Receivables Based finance profession.

Eligibility

Anyone employed with a company that offers factoring and has a minimum of two year's work experience in the Factoring Industry are eligible to participate. Candidates must also adhere to the CAEF Code of Conduct.

Commitment and Resources Candidates

Simply complete this application for processing. If approved you will be provided with a web site, user name and password where you can schedule to take the exam at a location near you at a time convenient for you.

All candidates who pass the exam will be designated an IFA Certified Account Executive in Factoring "CAEF". Persons who achieve the certification will be able to promote themselves as a CAEF and are authorized to use the logo for so long as their certification is active. Examination Administration

The IFA Certification test consists of a 100 multiple-choice question exam and candidates have two hours to complete the exam. The test is administered as a computer-based test and is offered in over 350 testing sites throughout the US and Canada.
